NOTE: This rebate is calculated on LAND only. Annual Farmland School Tax Rebates are available only to Manitoba residents and are limited to \$5,000 per taxpayer and any related persons, which includes your spouse or common-law partner and any corporation controlled by either of you. Applications for the 2020 property tax year must be received on or before March 31, 2021.
