## 224-19 KOWALCHUK-MODRZEJEWSKI

WHEREAS the Rural Municipality of Brokenhead Zoning By-Law 1688, as amended; Section 4.3.2 Table I – 'R' Residential Zone requires that fences and hedges located on the street side of a reversed corner site shall not exceed a height of 3.5 feet unless set back a distance of 15 feet, in which case said height shall not exceed 6 feet, *and* projections from dwelling and other main buildings – open, unenclosed porches, platforms at or below level of first floor

require a side yard setback of 3 feet, or 12 feet – the greater distance shall apply on the street side of a corner site;

**AND WHEREAS** Alicia Dismaya has made application for variation to permit to erect a 5 foot chain link fence on the street side of a reversed corner as well as along the entire front yard with a setback of 3" from property line and to construct a 5 foot wide side deck to wrap around the east side of the house having a 9 foot setback on the street side of a corner site on the premises of Lots 1 and 2, Block 4, Plan 1635 – 30 Pine Avenue, and;

**THEREFORE BE IT RESOLVED THAT** Application for Variation Order No. V-359-19 for Alicia Dismaya is hereby approved with the following condition:

1. That all fence materials provide a clear line of vision 15 feet from the corner of the fence.
