3.2 James Haier – Animal Control

Mr. Haier attended Council to discuss enforcement of the Animal Control By-Law with respect to barking dogs. He has made complaints about dogs barking in his neighbourhood and questions the evidence collecting procedures of Rural Animal Management Services. Mr. Haier adamantly requested that Council prosecute these by-law violations. Chief Administrative Officer Sue Sutherland had contacted the Animal Control Officers to discuss the incidents and each were consisting of a dog barking outside for 20-30 minutes, then being let inside which led to cessation of the barking. As the barking did not last for an extended period of time and was during the daytime, the incidents were not seen as violation of the Animal Control By-Law or Nuisance Noise By-Law and therefore did not require prosecutorial action. Mr. Haier was not satisfied with the explanation and left abruptly.

3.3 Curtis & Dawn Rossman – Speeding on St. Ouens Road

Mr. and Mrs. Rossman attended Council to discuss the need for more speed signage on St. Ouens Road. The area is inhabited by several families and is a popular starting point for tubers on the Brokenhead River. Vehicles have been witnessed travelling at twice the speed limit of 50 km/h. The sign that was installed in 2016 has been removed and left on the ground. Mr. Rossman requested more signage on either side of the community with the north sign being soon after exiting PTH #44. Signage painted on the pavement was also suggested as it cannot be removed. Administration will notify the Royal Canadian Mounted Police that there is concern in this area, and also contact the local Citizens on Patrol Program to keep watch or implement a speed monitoring sign.
