Incidents of harassment have occurred multiple times this year with respect to burning yard waste and issues with the direction of flow of the Brokenhead River. The materials being burned are clean burnables such as leaves, branches and grass clippings, and are burned in accordance with Fire Ban By-Law No. 2223-21. Licenses for building a dam on the Brokenhead River have been obtained from the Province of Manitoba and are inspect annually. Mr. Gafka is requesting that the member of council end the harassment while looking the other way when other residents are in contravention of the rules.

WHEREAS Council sat as a Conditional Use Board May 25th, 2021 to hear representation(s) in regards to an application submitted by Ron Modjeski and Karen McDonald to permit the operation of a 300 site camping and tenting ground, including travel trailers, in a 'P' Parks, Recreation and Institutional Zone on the property located at SW ¼ Section 8-13-8EPM – 73033 Road 43E – File No. C-77-21, and;

WHEREAS 4 representations were received in objection to the application;

THEREFORE BE IT RESOLVED THAT the Council of the Rural Municipality of Brokenhead approves this Conditional Use Application with the following conditions:

- 1. The Owner obtains all required permits from the Brokenhead River Planning District as per the inspection completed on June 3rd, 2021.
- 2. In future, the Owner of the land is responsible to obtain permits for permanent additions to any structure, decks over 24" in height, and any buildings over 108 square feet.
- 3. Liability insurance in the amount of \$2,000,000.00 with the Rural Municipality of Brokenhead as additional insurer and proof provided to the Municipality.

- 4. That all costs associated with the enforcement of this conditional use order to be found in non-compliance shall be borne solely by the Owner.
- 5. That all costs associated with this conditional use incurred by the Municipality shall be the sole responsibility of the Owner.
- 6. That the Owner is approved to have a total of 285 trailer sites, 15 tenting sites, and any intensification of operations will require a new conditional use application.
- 7. No permanent structures are to be located on the seasonal sites. Any placements must be portable.
- 8. Adequate signage must be provided stipulating the location and dates and times of operations.
- 9. Any signage outside the park is to have a permit from the Brokenhead River Planning District.
- 10. This order is subject to the rules and regulations stipulated in all aspects of the Rural Municipality of Brokenhead Zoning By-Law No. 1688, with specific focus on the Trailer Licensing By-Law No. 1934, Noise By-Law No. 2192-17, and the Burning Ban By-Law No. 2223-21, and any other superseding By-Law of the same nature.
- 11. Lease agreements/contracts with tenants must outline that the lease holders cannot interfere with acceptable farm practices.
- 12. Park signs should be posted to indicate that visitors/guests should not interfere with any livestock or agricultural nature outside the property boundaries of the campground.
- 13. Lease agreements/contracts with tenants must reflect all applicable bylaws of the Rural Municipality of Brokenhead.
- 14. The Owners will be responsible for providing dust control from the intersection at Mile 73N and Road 43E all the way to the Owner's residence access to the driveway of the campground which represents 1,100 feet of dust control. The Chief Administrative Officer of the Rural Municipality of Brokenhead at his/her discretion during dry and dusty seasons may require a second application of dust control for 300 feet in front of 73033 Road 43E and in front of 42158 Mile 73N. If the bill for dust control should go into arrears, the charges will be added to the property tax bill by resolution of Council.
- 15. That the Owner receives approval for all holding tanks on the property and permits for any further installation and provides written proof to the Brokenhead River Planning District.
- 16. Payments for Trailer Licensing Fees are to be paid in full by September 30th of each year. Any arrears will be charged to the property tax account.
- 17. Designated officers of the Municipality or the Brokenhead River Planning District will be allowed to enter the premises at any time for compliance inspections.

- 18. Any special event being held at the campground including but not limited to weddings, family reunions, meetings and concerts are to be approved by resolution of Council.
- 19. No fireworks are permitted without special approval of Council.
- 20. That this conditional use order is valid for a three (3) year term at which time the Owner must reapply for a new conditional use order, the commencement date is the date of approval.
- 21. The Owner is to provide to the Municipality a fire prevention plan and emergency plan.
