 - 3.1 Conditional Use C-77-21 SW ¹/₄ Section 8-13-8EPM

BE IT RESOLVED THAT the Council of the Rural Municipality of Brokenhead opens this Conditional Use Hearing, the time being 7:01 p.m., to hear Conditional Use File No. C-77-21, submitted by applicants Ron Modjeski and Karen McDonald.

Chief Administrative Officer Sue Sutherland presented the application to permit the operation of a 300 site camping and tenting ground, including travel trailers in a "P" Parks, Recreation and Institutional Zone. A list of proposed conditions was read aloud.

To speak in favour of the application was owner/applicant Karen McDonald who stated that she definitely wants to move forward.

Brett Steffes sent an email in support of the application, explaining that the campground is a benefit to many businesses in the area.

Andrew and Donna Lentz spoke in opposition to the application. Concerns expressed included:

-The same vehicles are driving past his property several times per day

-Campers and tubers have been trespassing on their private property, vandalizing their signs

-Traffic is fast and erratic

-Solar lights stolen off their property, food and liquor stolen from their house

-Dust control has to be fought for each year

-Road maintenance is required more often each summer

-If the last conditional use was for 200 sites, how did it get to 260?

Lee and Terry Loeb spoke next in opposition to the conditional use application. They live directly east of Great Woods Park and are opposed to 300 sites. Questions and concerns included: -Exactly how many sites are there presently? Owners provided information that there are 260 serviced sites and 14 unserviced. Of those, 160 are seasonal.

-How did the number of sites and collection of trailer fees go unchecked for so long? By-Law No. 1934 was passed in 1999? Council stated that none of the campgrounds and trailer parks have been charged fees. Administration has been in contact with Manitoba Assessment for more information.

-Who is responsible for enforcing the conditions? New seasonal campers will be required to provide a site plan and the building inspector will do site visits.

-The campground rules for quiet hours do not match the municipal by-law. Who is going to enforce this? The by-law officers can be sent to drive through the campground on patrol at night.

-Fireworks spook the horses.

-Campers have used the trails and further trespassed on their private property to see the horses. A barricade is needed, as the barbed wire fence does not appear to have any effect.

Andrew Lentz further inquired why residents on Golf Course Road weren't notified, as they see a lot of traffic to and from the campground on Road 43E. They were not within the 350 feet buffer zone around Great Woods Park.
