- 3. Delegations and Public Hearings
 - 3.1 Jason Gauthier & Breigh Kusmack Introduction

Mr. Gauthier and Ms. Kusmack attended Council to introduce themselves as the new owners of the Superior Inn & Suites. They updated Council on the improvements they have made to the hotel, what the next phase of changes are and future plans for more amenities. Council was invited to see the improvements and to discuss further changes to serve the community better.

3.2 Mark Geiger – Request for New Structure on Property

Mark and Deanna Geiger attended Council to request permission to place a small pre-fabricated home and a garage/storage shed on their property on Road 43E. The house meets the criteria for size and will be placed on a temporary foundation as the property is located next to the Brokenhead River. The garage/shed will remain on skids. Both structures would be easy to remove should flooding occur. As the proposed buildings meet requirements of the Zoning By-Law and the development agreement, Council will allow them to be moved on.

3.3 Diane Robertson – Notification of Conditional Use

Mrs. Robertson attended Council to voice her opposition to the proposed Westfarm Colony. *The Clipper Weekly* published information for providing your views to the Technical Review Committee in their December 23rd, 2021 edition, with a deadline of January 24th, 2022. Mrs. Robertson feels with the holiday season, this did not provide enough time to compose thorough arguments. The radius of people notified by mail of the technical review process was 3 km and this distance was not nearly enough to encompass everyone that is affected by the proposed operation. Mrs. Robertson is asking for a 10 km buffer zone for mailed out notices for the Conditional Use hearing regarding the intensive livestock operation to allow more animal units than permitted in an A-80 zone. Another request was to change the zoning by-law's definition of communal farm to exclude factory farms. Wells were

drilled behind her property without notification, although a license is only granted once volume to be used is determined.

Council explained that the Technical Review Committee has taken all the submissions and reviewed them. Any questions will be clarified with Westfarm Colony. The TRC will provide a recommendation to Council before a Conditional Use hearing is scheduled. This hearing will be held in a large venue, allowing all who wish to speak to attend. If the colony or the objectors are unhappy with the decision, they can appeal to the Municipal Board for review.

3.4 Jordan & Amanda Fournier – Request for Shop on Property

Mr. and Mrs. Fournier attended Council to request permission to construct a 36' x 60' shop in front of their house. The Zoning By-Law does not allow a shop to be built in the front yard of Rural Residential lots. The shop is to be used for storage of equipment as well as provide an office and workspace for Mrs. Fournier's home business of online sales. A Conditional Use would need to be applied for and Variations may be required to allow a business to be held in a Rural Residential zone. Mrs. Fournier is looking for a building in Beausejour to work out of, but this shop would be to transition and allow for growth of business until a new facility is acquired. Mr. and Mrs. Fournier will need to contact the Brokenhead River Planning District for more information and to obtain applications for the necessary steps to be taken.
