- 3. Delegations and Public Hearings
  - 3.1 Cindy & Mark Buss Request to Name Portion of Road 47E (South) Buss Road

Cindy and Mark Buss attended Council to request that Road 47E, from PTH #44 south 2 ½ miles to the railroad track, be named Buss Road. Council was provided with a brief history of the family living in the Golden Bay area since 1910, farming and raising families in those 112 years. Council was receptive to the request, but also recognized that this matter should be brought to the Rural Municipality of Brokenhead Municipal Heritage Advisory Committee.

3.2 Robert Ripcik – Request for Kennel License

Mr. Ripcik attended Council to request a Kennel License for his 10 adult dogs on his property located at NE <sup>1</sup>/<sub>4</sub> Section 33-14-7E. The dogs are Caucasian Ovcharkas and they are trained for protection and guard duty. Given the nature of the training the dogs are receiving, Council is adamant that they are contained and cannot leave the property unsupervised. Council will discuss the Kennel License and ensure adequate conditions are included.

3.3 Jane Seniw – Garson Heritage

Mrs. Seniw attended Council to discuss heritage issues in the municipality. One project the Municipal Heritage Advisory Committee (MHAC) would like to see completed is the placement of historical signage at the four designated heritage sites in the municipality. These include Gabels Store, Sts. Peter and Paul Ukrainian Orthodox Catholic Church, St. Michaels Bell Tower, and St. Andrews Church. The issue is that three of the sites are adjacent to Provincial roads.

There is much information that could be shared about the quarries. Installing storyboards would educate the public and create an active transportation trail for pedestrians and cyclists interested in history.

Mrs. Seniw also expressed frustration with changes proposed to be made at Garson Memorial Park on Gillis Street. No input from residents or the MHAC were sought out with respect to the proposed work to take place.
